Acquisition and Capital Raising

On the 21st of April, the Company entered into a binding heads of agreement with Bombora Natural Energy Pty Ltd to acquire all of the issued capital of the Bombora on the basis of 6 fully paid ordinary shares in Zeta for every 11 fully paid shares in Bombora, resulting in the issue of approximately 27,835,200 Zeta Shares.

The acquisition is subject to and conditional upon the satisfaction of various conditions precedent including: the obtaining of all approvals from Zeta shareholders; confirmation from the ASX that listing rule 11.1.3 will not apply; and other conditions as outlined in the heads of agreement as announced.
